



Kinder Ground And Your Privacy

Your privacy is important to us. This Privacy Statement is meant to clarify what data we collect, why we collect it, what we do with it, and the choices available to you when using any of our websites or other services. We will not use or share your information with anyone except as described in this Privacy Policy. This Privacy Policy does not apply to information we collect by other means including offline, related to Kinder Ground funded projects, or from other open/freely accessible sources.

Information We Collect

User-Provided Information: You provide us information about yourself, such as your name and e-mail address, if you donate to Kinder Ground, contact us via email, fill out a form, or connect with our social media (including by “following,” “liking,” linking your account to Kinder Ground.org, etc., on a third-party website or network). If you correspond with us by email or through populating a form on our website's domain, we may retain the content of your email messages or responses.

Cookies

At Kinder Ground, the security of your information and the experience you have when visiting our websites is important to us. We use cookies and similar technologies to assist us in these areas. For example, these technologies are used for storing and processing preferences and settings and capturing information about how our websites and emails are used. We may also use information collected through automated technologies on our websites and emails for interest-based advertising. You may limit how we and our service providers utilize these technologies through your browser settings or by visiting sites that provide interest-based advertising, as described more fully below.

If you are accessing our websites from the European Union and certain other countries, you will be presented with an additional opportunity to accept or block the use of cookies. You may block the use of certain cookies via your browser; however, this may limit your use of our services and products.

Analytics

Kinder Ground will work with service providers to enhance and improve our websites, products, and services. These providers supply tools for traffic monitoring, interest-based advertising, surveys, social media advertising, and email marketing. Kinder Ground may use Google Analytics or other resources for this purpose. Kinder Ground monitors site traffic and technical performance to administer our websites, to improve our visitors' experiences, evaluate site usage, and provide site security. By providing Kinder Ground your email address (including by “following,” “liking,” linking your account to KinderGround.org on a third party website or network), you consent to our using the email address to send you Kinder Ground-related notices, including any notices required by law. You also agree that we may send you notifications of activity on KinderGround.org to the email address you give us, in accordance with any applicable privacy settings. We may use your email address to send you other messages containing relevant information, such as newsletters, changes to features of KinderGround.org, or other information related to requests that you submit to our email account. If you do not want to receive such email messages, you may opt out by unsubscribing through the link provided on the email or by contacting us at Kinder Ground info@kinderground.org.

Kinder Ground reserves the right, but has no obligation, to monitor the user content you post on KinderGround.org and any of our social media sites. We reserve the right to remove any such information or material for any reason or no reason, including without limitation if in our sole opinion such information or material violates, or may violate, any applicable law or to protect or defend our rights or property or those of any third party. Kinder Ground also reserves the right to remove information upon the request of any third party.

How We Share Your Information

Personal Information: Kinder Ground will not rent or sell your personal information to others. Kinder Ground may share your personal information with third parties for the purpose of providing Kinder Ground services to you. If we do this, such third parties’ use of your information will be bound by this Privacy Policy. We may store personal information in locations outside the direct control of Kinder Ground (for instance, on servers or databases co-located with hosting providers).

Any personal information or content that you voluntarily disclose for posting to KinderGround.org or our social media sites, or that you affirmatively consent to make public, becomes available to the public, as controlled by any applicable privacy or website customization settings. If you remove information that you posted to KinderGround.org or our social media sites, copies may remain viewable in cached and archived pages, or if other users have copied or saved that information.

Except as otherwise described in this Privacy Policy, Kinder Ground will not disclose personal information to any third party unless required to do so by law or subpoena or if we believe that such action is necessary

to (a) conform to the law, comply with legal process served on us or our affiliates, or investigate, prevent, or take action regarding suspected or actual illegal activities; (b) to enforce this policy, take precautions against liability, to investigate and defend ourselves against any third-party claims or allegations, to assist government enforcement agencies, or to protect the security or integrity of our site; and (c) to exercise or protect the rights, property, or personal safety of Kinder Ground, our users or others.

How We Protect Your Information

Kinder Ground cares about the integrity and security of your personal information and takes reasonable safeguards to maintain that security. We cannot, however, ensure or warrant the security of any information you transmit to Kinder Ground or guarantee that your information on the service may not be accessed, disclosed, altered, or destroyed by breach of any of our physical, technical, or managerial safeguards. Your privacy settings may also be affected by changes to the functionality of third-party providers, such as social networks. Kinder Ground is not responsible for the functionality or security measures of any third party.

Your Choices About Your Information

Children's Privacy
